Product Description: A white, neutral beeswax blend with distilled mineral oil formulated as a paste or liquid wax. Polish and Sealer are FDA approved for food safe contact. Effects waxes are prepared with non-toxic mica powders, but are not FDA approved for food safe contact and are not intended for cosmetic use

Base Appearance: White Translucent paste or liquid

Odor: Low odor of beeswax VOC Rating: Zero VOC

Product Use: For use with or without pigmentation on wood, flat paint, plasters and absorbent surfaces. Creates a clear, hard non-toxic wax finish. Not for use on floors.

Section II – Health and Flammability Rating HMIS Code

Section III - Identification of Dangers

Flammability- Product is combustible in its wet paste or liquid form.

Skin Contact- Product may cause skin irritation or dermatitis in sensitive individuals in wet paste or liquid form.

Section IV – Precautions for safe use and handling and storage of wax paste

Ventilation – General ventilation is sufficient for use with this product

Skin Protection – Gloves to protect skin during application

Respiratory Protection – Unnecessary under general ventilation

Handling – Wash hands with soap and water if skin contact occurs. Wash clothing that has been in contact prior to wearing.

Storage – Keep out of reach of children. Container must be closed tightly to prevent evaporation and hardening. Protect from freezing. Do not store near heat, sparks or flame. Allow residue of product on application rags or tools to dry prior to disposal. Dispose of excess in designated landfill.

Section V – Emergency First Aid Procedures

Inhalation – If overcome, remove to fresh air.

Eye Contact – Flush with large amounts of water. Check with an ophthalmologist if irritation occurs.

Skin Contact – If irritation occurs, flush with water for 15 minutes. Seek medical attention if dermatitis occurs.

Ingestion – In case of insignificant amount (less than a mouthful) rinse with water and refer to a doctor. In case of ingestion of large amount, do not induce vomiting. Seek medical supervision and present MSDS.
